Sessional Order of Proceedings

The order of business for the day is set out in the agenda.

SATURDAY, February 28, 2026 - The session will begin at 9:00 am with a Eucharist celebrated by the Most Reverend Anne Germond, Metropolitan of the Ecclesiastical Province of Ontario. Following the Eucharist, Synod will convene with the Most Reverend Anne Germond chairing the session. At that time the administrative business of Synod will be conducted. After receiving the list of nominations, Synod will proceed with the election process as outlined in the agenda.

PRAYER VIGIL

Synod will be continuously held in prayer by people from parishes across the Diocese. Many of these people will be present in the Good Shepherd Chapel at the Cathedral and members of Synod are invited and encouraged to join them.

ACCOMMODATIONS

Accommodations are the responsibility of the Synod member.

LOCATION AND PARKING

Parking is available near the Cathedral at parking garages along Queen Street between Bronson Avenue and Lyon Street. [Regular public transit routes](#) to the downtown Parliament Hill area will easily get you close to the Cathedral, and the Lyon Station for the O-Train is just down the street. There is no free street parking close to the Cathedral on Saturday.

The most accessible entrance to the Cathedral is through the glass entranceway at 414 Sparks Street, Ottawa, which is wheelchair accessible. Alternatively, access to the cathedral can be gained through the entrance at 439 Queen Street, Ottawa.

MEALS

There will be a light refreshment break following the Eucharist. A boxed lunch will be provided at a convenient time mid-day.

FEES AND REGISTRATION

There are no fees for this Synod. Registration will be online only. Registration begins on Monday, January 26, 2026 and must be completed no later than Sunday, February 8, 2026. Parish Incumbents are responsible for registering parish members, including parish clergy. Diocesan staff, including Executive Directors of Community ministries, will be registered by the Bishop's Office. Officers of Synod will be registered by the Synod Secretaries. Diocesan Council members, retired clergy (who were elected to serve as members of Synod at the October 3, 2026 meeting of retired clergy), and other clergy under the jurisdiction of the Bishop of Ottawa (including military chaplains), are responsible for registering themselves.

Glossary of Terms

Chair of Synod

The Canons, Bylaws and Regulations (CBR) of the Anglican Diocese of Ottawa state that the Metropolitan of the Ecclesiastical Province of Ontario is to chair the meeting of the Electoral Synod.

Chancellor and Vice-Chancellor

These terms refer to members of the legal profession appointed by the Bishop to advise Synod on legal, procedural and other related matters. Henry Schultz is the Chancellor and the Vice-Chancellor is Marian McGrath.

Electoral Synod

This is a meeting of Synod summoned for the purpose of electing a Bishop.

Electoral Synod Member

Only Members of the Electoral Synod are permitted to vote at that Synod. Members of the Electoral Synod are either Lay members or Clerical members. Lay members of the Electoral Synod are chosen as follows:

- at its Annual Vestry meeting, each parish elects a Synod member or members to share in the deliberations of the Synod, and this includes membership in the Electoral Synod. Pursuant to Bylaw 3.01(6), all lay persons who were selected by their parishes to attend the Annual Synod of 2025 are automatically members of the Electoral Synod of 2026;
- the Chancellors, the Lay Secretary of Synod and all persons who were members of Diocesan Council at the time of the 2025 Annual Synod are automatically members of the Electoral Synod; and,
- the Bishop of Ottawa also has the right to appoint up to 15 lay persons as members of Synod.

All persons on the Clergy List of the Diocese, including Parish Incumbents, Associates, Assistants, and Other Clergy Under the Jurisdiction of the Bishop of Ottawa (including military chaplains) are also members of the Electoral Synod by virtue of their office.

As specified by the Canon 2.02, up to ten percent of retired clergy are also eligible to become members of the Electoral Synod. These are chosen by a selection process overseen by the Secretaries of Synod.

Minutes Review Committee

This committee is a sessional committee, appointed only for the duration of its task. Its responsibility is to review the minutes taken at a Synod for accuracy and clarity. The committee ceases to exist once it has completed its review. Once reviewed by the committee, the minutes are presented to the next session of Synod for correction and approval.

Resolutions Committee

This is a sessional committee, and ceases to exist after the conclusion of each Synod. The primary role of the committee is to review motions prior to their being discussed by the

Synod. The committee ensures that the motions make sense and will achieve what the mover and seconder of the motion intend.

Secretaries of Synod

There are two Secretaries of Synod. The Lay Secretary is elected by Diocesan Council for a three-year renewable term to represent the Laity of the Diocese. The Lay Secretary is Margaret Porter. The Clerical Secretary is appointed by the Bishop to represent the Clergy of the Diocese. The Clerical Secretary is the Rev. Canon Stephen Silverthorne. The Secretaries work on our behalf to oversee meetings of Synod and to follow up on the motions and initiatives arising from Synod meetings. The Secretaries are also responsible for the work of the Diocesan Council which has the task of overseeing the work of the Diocese between meetings of Synod.

Scrutineers Committee

The committee is led by the head of Scrutineers, and its membership is appointed at the beginning of the Electoral Synod. Scrutineers are responsible for counting votes cast at the Synod. Scrutineers' term of service comes to an end at the conclusion of the Synod at which they were appointed.

Synod

The term refers to the meeting or council of the clergy and people of the Diocese. The term also refers to the legal name of the Diocese, the Incorporated Synod of the Anglican Diocese of Ottawa.

Votes by Orders

Voting at the Electoral Synod is conducted by orders (also known as houses). This means that **clergy and laity** vote separately, and their ballots are tallied separately. To be elected, a nominee must receive a majority of votes from both orders.

MEMBERSHIP OF ELECTORAL COMMITTEES

EPISCOPAL ELECTION COMMITTEE

The Episcopal Election Committee (EEC) is an ad hoc committee of Diocesan Council, whose activities are prescribed by Canon 2.06, and Bylaws 2.05 and 2.09. As directed by the CBRs, the committee's membership is appointed by Diocesan Council. The EEC includes people with a wide range of skills, experience, and geographical perspectives, and is chaired by the Secretaries of Synod. The membership of the committee is listed below.

SUPPLEMENTARY NOMINATIONS COMMITTEE

The Supplementary Nominations Committee is an ad hoc committee of Diocesan Council, whose activities are prescribed by Canon 2.07 and Bylaw 2.06.1. Its key responsibility is to nominate to the office of Bishop eligible individuals, including individuals who are not resident in the Diocese, in the interest of enhancing the diversity of candidates in the electoral process.

As directed by the CBRs, the committee's membership is appointed by Diocesan Council. The committee membership is listed below.

Canon 2.12 – The Electoral Synod

1. A quorum of the Electoral Synod shall comprise half of the Lay Members registered and entitled to vote and half of the Clerical Members registered and entitled to vote.
2. The Electoral Synod shall be chaired by the Episcopal Officer.
3. The Secretaries of Synod shall report at the beginning of the Electoral Synod on the number of Lay Members and Clerical Members who are in attendance and duly registered.
4. If the report of the Secretaries of Synod indicates that there is not a quorum present, the Electoral Synod shall be adjourned without debate to a date within the next ensuing three months.
5. Voting shall be by Order, by successive ballots. A nominee is elected when he or she has received a majority of votes in both Orders. The Chair shall not have a vote.
6. If after three ballots no nominee has been elected, then the nominee who has attained the lowest combined percentage, determined by adding A + B, for each candidate, shall be dropped for each succeeding ballot until a nominee is elected or the number of nominees has been reduced to two. For making this determination:
 - a) A is the percentage of Clergy votes that a candidate has received; and
 - b) B is the percentage of Lay votes that a candidate has received.
7. If during the course of the Electoral Synod the number of persons who are present and vote in either Order (but not both Orders), as confirmed by the Secretaries of Synod, falls below 50% but not less than 20% of those registered and entitled to vote (the "Deficient Order"), the Electoral Synod shall proceed, but on the basis that a nominee is elected when he or she has received at least two-thirds of the votes in the Deficient Order and a majority of votes in the remaining Order.
8. If during the course of the Electoral Synod the number of persons who are present and vote in either Order falls below 20% of those registered and entitled to vote, or the number of persons who are present and vote in both Orders falls below 50% of those registered and entitled to vote, as confirmed by the Secretaries of Synod, then the Electoral Synod shall be adjourned without debate to a date within the next ensuing three months as appointed by the Chair.
9. If during the course of the Electoral Synod the number of nominees on the ballot remains two throughout three successive ballots, then the Episcopal Officer may in his or her discretion adjourn the Electoral Synod to a date within the next ensuing three months as appointed by the Chair.
10. If an Electoral Synod is adjourned because it has lost quorum or because it has failed to elect a nominee, then a new Electoral Synod shall take place following the same procedures as though the former meeting had not taken place.

11. If during the course of the Synod the number of nominees remaining on the ballot is one, then that person shall be considered to have been elected once a further vote is taken on the question "Is it your will that this person become the Bishop of Ottawa?" and the vote is in the affirmative based upon votes cast according to the percentage provided for in this Canon.
12. If a nominee cannot be present for the election, the nominee may, by written notice to the Secretaries of Synod, delegate a person to be present on their behalf, but such person shall not have voting privileges unless a member of the Synod in their own right. A nominee who is elected must personally give consent to the election to the Chair.
13. Before the Electoral Synod is adjourned the newly-elected bishop is welcomed and all who have offered themselves for this discernment process are thanked.
14. Any nominee for the office of Bishop who is not a member of Synod is entitled to vote in the Electoral Synod, provided that the name of the nominee has not been dropped from the ballot in a manner consistent with this Canon.
